MORE THAN STITES & HARBISON

Rebecca has a long history of civic and community service, including as a member of the board of directors for the Leadership Louisville Center, Jewish Hospital & St. Mary's Foundation, The Kids Center for Pediatric Therapies, and Dress for Success Louisville. Rebecca is also a founding member of [give]502 and a past President of the Board of Directors for the Young Professionals Association of Louisville (YPAL).

Rebecca was named to the "Forty under 40" list by *Business First of Louisville* in 2013. She currently serves on the Economic Development Committee for Greater Louisville, Inc. In that role, she weighs in on potential federal and state legislation that may affect her clients and their employees.

Rebecca is also cancer survivor—a badge she wears proudly. In 2016, weeks before her daughter's first birthday, Rebecca was diagnosed with a very rare, acute leukemia. The cancer is so rare it had no standard recommended course of treatment at the time of her diagnosis.

Although devastated by the prognosis, Rebecca refused to yield. Instead, she became her own advocate and found hope in a brand new targeted chemotherapy being offered through an FDA-approved clinical trial. After four rounds of the clinical trial therapy, Rebecca received an allogeneic bone marrow transplant—the only potential cure for an acute leukemia like hers.

Rebecca is now alive and well thanks to ground-breaking research that led to creation of her clinical trial drug and the selfless bone marrow donation of a complete stranger.

Rebecca's cancer battle reflects the same grit and determination she brings to her legal practice. She is undaunted by challenges, and serves her clients as both a trusted counselor and tenacious advocate.
