## RECENT ASSIGNMENTS

- Lead counsel for the plaintiff in an LLC membership dispute that went to trial, obtaining an award in excess of \$500,000, including punitive damages.
- Appointed as Special Justice to the Kentucky Supreme Court in the case of *Megronigle v. Allstate Property & Casualty Insurance Company*, 671 S.W.3d 293 (Ky. 2023).
- Co-counsel for Churchill Downs Incorporated in defeating a motion for preliminary injunction and obtaining dismissal of all claims in litigation brought by Bob Baffert.

- Obtained multiple dismissals and summary judgments in data breach class actions brought in state and federal court, and has favorably settled various others..
- Obtained summary judgment for multiple defendants in a putative class action alleging a host of claims, including alleged RICO violations and fraud, relating to the enforcement of tax liens. Judgment was unanimously affirmed on appeal by the Sixth Circuit. *Brown v. Tax Ease Lien Servicing, Inc.*, 776 Fed. App'x. 291 (6th Cir. 2019).
- Obtained summary judgment, unanimously affirmed on appeal, in a putative class action alleging breaches of fiduciary duty and other claims against attorneys in connection with their representation of plaintiffs in prior putative class actions. *Doe v. Golden & Waters, PLLC*, 2019 WL 489111 (Ky. Ct. App. Feb. 8, 2019).
- Successfully defended captive insurance manager and related parties in arbitration proceedings involving alleged fraud and other misconduct, obtaining award rejecting every claim asserted following a six-day hearing.

- Successfully argued multiple appeals concerning fiduciary duty and diversion of business opportunities for limited liability companies, including the proper measure of relief, matters of first impression in Kentucky. *Patmon v. Hobbs*, 495 S.W.3d 722 (Ky. Ct. App. 2016) and *Patmon v. Hobbs*, 280 S.W.3d 589 (Ky. Ct. App. 2009).
- Successfully argued matter of first impression regarding the proper application of Kentucky condominium law to a riverfront marina. *Steenrod v. Louisville Yacht Club Association, Inc.*, 417 S.W.3d 234 (Ky. Ct. App. 2013).
- Successfully tried commercial lease dispute resulting in judgment in favor of client in all respects, which was affirmed on appeal. *Thirteenth Floor Entertainment Ctr., LLC v. Louisville Galleria, LLC*, 507 Fed. Appx. 473 (6th Cir. 2012).
