RECENT ASSIGNMENTS

- Derrick Bingham and Dan Millman successfully defended Heard County, Georgia's decision denying a special use permit application for a 700 acre \$150 million solar farm, and obtained favorable rulings on issues of first impression under Georgia's newly enacted Superior Court Appellate Practice Act.
- Dan Millman and Shannon Sprinkle obtained an anti-SLAPP dismissal and judgments awarding all trial court and appellate court fees on behalf of a law firm sued over and HOA dispute.
- Dan Millman wins dismissal of a developer's claims against a small Georgia town, its city council members, and its city attorney, and obtains sanctions against the developer.
- Shannon Sprinkle and Dan Millman secured summary judgment for their law firm client accused of malpractice arising out of disputes over a confirmed bankruptcy plan.

Claims included RICO, malpractice, negligent misrepresentation, breach of fiduciary duty, and fraud. Our client was one of only six defendants who were dismissed by the 251 page order.
- Georgia Court of Appeals Affirms Summary Judgment Shooting Down Damages Claim (January 2023). Dan Millman and Joe Kingma prevailed for a Georgia municipality which had denied a liquor license. While Court of Appeals did not address whether the applicant was entitled to the license it agreed that damages for lost profits were not available.
- Shannon Sprinkle and Dan Millman defeated ADA claims against a recruiting firm and a staffing company in *Akins, v. Cella, Inc.*, 2022 WL 688847 (N.D. Ga. July 18, 2022) and *Levins v. Connect Staffing, Inc.*, 2022 WL 2187109 (N.D. Ga. May 31, 2022). In both cases, the court agreed that the employers' termination decisions were lawful and justified based on the employees' actions.
