Most recently, she served as the President/Executive Director of the Kentucky Association of Health Care Facilities/Kentucky Center for Assisted Living, where she grew the association membership by 30%, created the first assisted living community chapter, and successfully advocated for increased Medicaid funding and regulatory reform. Betsy serves on the American Health Care Association Legal Committee.
