- *Commonwealth v. David Owen*. Our client was a health care worker at Owensboro Hospital who was charged with sexually assaulting a patient during an EEG examination. In a high profile trial, our client was acquitted of all charges.
- *Commonwealth v. James Mallory*. The firm was hired by a major American corporation to represent Mr. Mallory in a death penalty case.
