## RECENT ASSIGNMENTS

---

- Successfully defended an AMLAW 200 firm in a legal malpractice case arising from international patent applications. Following a multi-week trial, the jury returned a verdict of less than 1 percent of the damages sought by Plaintiffs.
- Successfully upheld summary judgment grant in favor of international accounting firm on appeal.
- Favorably resolved potential claims brought against auditors arising out of an acquisition transaction avoiding costly litigation.
- Secured settlement for a national law firm resolving claims from bankruptcy trustee and lender arising from a \$25 million dollar defaulted loan avoiding expected litigation in multiple venues.

- Shannon Sprinkle and Dan Millman secured summary judgment for their law firm client accused of malpractice arising out of disputes over a confirmed bankruptcy plan.
- Successfully negotiated a favorable resolution of arbitration claims arising out of alleged failures in a Managed Services Agreement after the claimant suffered a cyber-breach resulting in the misdirected payment of several hundred thousands of dollars in vendor payments.
- Negotiated the successful resolution of legal malpractice claims asserted against a national law firm arising out of the previous settlement of hundreds of FLSA claims totaling several million dollars. The settlement reached for our client was less than the anticipated costs of defense of the claim.
- Shannon Sprinkle and Dan Millman defeated ADA claims against a recruiting firm and a staffing company in *Akins, v. Cella, Inc.*, 2022 WL 688847 (N.D. Ga. July 18, 2022) and *Levins v. Connect Staffing, Inc.*, 2022 WL 2187109 (N.D. Ga. May 31, 2022). In both cases, the court agreed that the employers' termination decisions were lawful and justified based on the employees' actions.
